4.1 For officers of 1978 Batch

(i) the officers were in service as on 01.07.1991.

(ii) the officer has reached the maximum of the scale of pay of Grade-IV (J.C.) and remained there for a period of two years on 01.07.1991.

4.2 For officers of 1979 Batch

(i) the officers were in service as on 01.07.1992.

(ii) the officer has reached the maximum of the scale of pay of Grade-IV (J.C.) and remained there for a period of two years on 01.07.1992.
