

Dear Colleagues,

As you are aware, India is the Global Host of **World Environment Day** being celebrated on 5th June 2018. I would request that all formations in CBIC to suitably celebrate the World Environment Day by organising clean-up, walks to raise awareness, planting of trees and other environment-friendly measures.

2. In this context, I would like to remind you that the work related to installation of LED lights, energy saving fans/air-conditioners was supposed to have been completed by 31.03.2018 with the help of M/s EESL. The progress in this regard needs to be monitored by you for completion within the next two months without fail. Similarly, installation of solar panels on roof top of Government buildings needs to be accelerated as per instructions already issued, within the next two months.

3. In the current financial year Rs. 49 crores has earmarked for action under Swachhta Action Plan, 2018-19 and only about Rupees One crore has been utilised till now. Please identify and implement environment friendly "Green Projects" like installation of rain water harvesting system, sewage treatment plant, replacement of existing sanitary fittings with those that consume less water, etc.

4. Please send a report to DG,HRD about the activities undertaken under your leadership to celebrate World Environment Day, 2018 within a fortnight.
